C. Income Information

IRS Data Retrieval Tool - Using the IRS Data Retrieval Tool (IRS DRT) that is part of FAFSA on the Web at www.fafsa.gov is the fastest, easiest, and most secure way to meet most of the requirements for verification. This option is available within 2 – 3 weeks after your tax return has been filed. If you did not utilize this feature when you filed the FAFSA, you may make a correction to the FAFSA and follow the steps as they appear in the financial section.

OR

2015 Tax "Return" Transcript – If you are unable or choose not to use the IRS DRT, you must provide a 2015 Tax "Return" Transcript, which you must request from the IRS. Go online to www.irs.gov and under "Tools" click on "Get a Tax Transcript," then click "Get Transcript by Mail."

Make sure you get the Tax Return Transcript and NOT the Tax Account Transcript. You may also order one to be mailed by calling 1-800-908-9946.
